The County's Fall Festival to End Hunger is back! The County's Fall Festival to End Hunger is a music and food festival held annually at Big Rock Mountain in Mars Hill on the first Saturday in October. Last year, The County added an ATV ride-in and golf tournament. The entire event raised over \$45,000 for local food pantries and the Meals on Wheels program. This year, they're bringing back fall foliage rides up the mountain on Big Rock's new chairlift in order to drive more attendance.

This year's event will happen rain or shine on Saturday, October 4, with multiple activities going on simultaneously. From a cornhole tournament to bounce houses and fall foliage rides, there is something for everyone to enjoy while raising money for a great cause. Headlining the musical acts that day is Motor Booty Affair, a group known for lighting up stages across America with their tributes to some of the greatest musicians of all time.

"The Fall Festival to End Hunger has been growing over the last two years, and we're proud to use the proceeds from that event to support our communities," said Dan Bagley, Executive Vice President of The County. "Our motto of 'People Helping People' drives us to push harder and achieve more. Everything we raise goes back into local food pantries for our friends and neighbors."

In 2024, The County donated \$10,000 to Meals on Wheels, achieving the Champion for Aging status with Aroostook Agency on Aging. This status means that The County is providing resources for Meals on Wheels to address the needs of older people in our community, ensuring they continue to live in their home communities with dignity and support.

"We are seeing the need for extra support rise in our communities," said Chris Beaulieu of the Aroostook Agency on Aging. "The County has been remarkable in consistently supporting the Meals on Wheels program. Their primary fundraising event, the Fall Festival to End Hunger, has been the driver for their increased sponsorship, year over year."

# **Trusted Contact Person**

#### What is a Trusted Contact Person?

A Trusted Contact Person is a person you designate who may be contacted if The County is concerned you are experiencing fraud, a health crisis, or another emergency that affects your financial affairs. You should choose someone you trust who is reliable and has your best interests at heart. You can choose a family member, friend, attorney, or someone else.

Consider choosing multiple trusted contacts, in case the first person is unavailable or is involved in a suspicious situation.

### When will The County contact my Trusted Contact Person?

The County may (but is not required to) contact your Trusted Contact Person under the following circumstances:

- 1. has questions or concerns about your health (capacity and well-being, etc.), your welfare (endangerment, self-neglect, etc.), or possible financial exploitation or fraud:
- 2. needs to confirm your contact information;
- 3. needs to confirm the identity of a new individual or entity that has been given legal authority to act for you (for example, an agent to whom you have given power of attorney, a successor trustee of a trust for which you are trustee, or a court-appointed guardian, conservator, or executor); or cannot contact you.

Because you can designate multiple trusted contacts, we recommend that you establish a primary contact for the credit union to contact first, before other named trusted contacts, and/or if the primary is unavailable or involved in a suspicious situation.

#### What information will be provided to my Trusted Contact Person?

If any of the above circumstances occur, The County may contact and provide information about you and your account(s) to your Trusted Contact Person. However, if we suspect the Trusted Contact Person may be involved in the fraud or financial exploitation, we will not contact the Trusted Contact Person.

Your Trusted Contact CANNOT view your account or make any transactions or decisions about the account unless they have some other legal authority (such as guardianship or POA). We recommend choosing someone other than a conservator, trustee, executory, or POA as your Trusted Contact.
